It is anticipated that Lake Wanahoo will be a major part of the project recommendation, but nothing is for sure until then. 2) A proposed resolution which would commit the Nebraska Game & Parks Commission to take Wanahoo as a state recreation area after completion is being considered. 3) The COE requested \$100,000 more funds into the established escrow account to keep on track with the Wanahoo feasibility study. Our participation is this study has been previously approved by the Board and costs will be shared with the City of Wahoo and Saunders County. Nelson made the motion, seconded by Sabatka, to approve submitting \$100,000 into the escrow account for the COE Lake Wanahoo feasibility study, provided that this expense plus any interest is shared equally with the City of Wahoo, Saunders County and LPNNRD. The City of Wahoo has an energy efficiency program for businesses. Breunig explained that one item which is eligible is installing energy efficiency lights in the NRD office. The total cost of the conversion is \$4,280. The City is offering a 0% loan for doing the conversion which is amortized over a 72 month period. The cost to the NRD for the program is \$50.39 per month which will be added to the electricity bill. The more efficient lights will save \$37.81 per month so the increase cost to the NRD over the 72 months is \$12.58 per month. Daufeldt, made the motion, seconded by Bull, that the NRD take advantage of the electrical efficiency program offered by the City of Wahoo and install the lighting retro-fit as attached to the Executive Committee Minutes.
