Soncksen reported that 30 million dollars worth of EQIP Funds were allocated statewide.

Director Langemeier briefed the Board on the upcoming NARD Board Meeting.

#### 5. APPROVAL OF MINUTES

Sabatka made the motion, seconded by Shelso, to approve minutes from the October 25, 2004 Board Meeting. Motion carried on consent agenda.

Busing Lawsuit and Complaint - Action on 18 MUD Permits to drill

Ms. Moorer on behalf of the Busing's stated her belief that the NRD was in violation of not properly posting the agenda item. Members from the audience also protested.

Jedlicka made the motion, seconded by Shelso, that the staff of the Lower Platte North Natural Resources District (LPNNRD) be instructed to issue well permits to Metropolitan Utility District (M.U.D.) pursuant to M.U.D.'s eighteen (18) Applications for Permit to Construct Water Wells subject to the following six (6) conditions, to wit:

#### a. Flow Meters

- 1) M.U.D. will place a flow meter on each production well, whether they are existing or to be drilled, within the jurisdiction of LPNNRD.
- b. M.U.D. will submit an annual report to LPNNRD setting forth the data collected from each flow meter. This requirement may be complied with by providing LPNNRD with a copy of the Annual Modeling Report to be submitted to the Army Corps of Engineers (COE), provided this information is contained therein.

# b. RDX and TCE Sampling

- a M.U.D. will conduct a sampling of all monitoring wells for RDX and TCE at least annually.
- b. M.U.D. will submit an annual report of these samplings to LPNNRD. This requirement may be complied with by providing LPNNRD with a copy of the Annual Modeling Report to be submitted to the Army Corps of Engineers, provided this information is contained therein.

#### c. Data Loggers

- a. M.U.D. will install data loggers on all monitoring wells.
- b. The data loggers will be set to record data at least on a daily basis.
- c. M.U.D. will submit an annual report of the data loggings to LPNNRD or allow LPNNRD access to the monitoring wells and data loggers. This requirement may be complied with by providing LPNNRD with a copy of the Annual Modeling Report to be submitted to the Army Corps of Engineers, provided this information is contained therein.

#### d. Compliance With Other Regulatory Conditions

- a. M.U.D. will comply with (1) the 404 Permit issued by the COE, as such permit is interpreted and enforced by the COE, and (2) the Agreement entered into by M.U.D. and the Nebraska Game & Parks Commission.
- b. M.U.D. will provide to LPNNRD copies of all past and future reports submitted to the

COE to comply with the 404 Permit, including the comprehensive ground water model of the area.

- e. As required by the COE's 404 permit for M.U.D.'s Platte West Project, and subject to the oversight and schedule of the COE, M.U.D. shall complete a comprehensive ground water model of the area which includes both of M.U.D.'s Platte West well fields (Saunders and Douglas Counties), the City of Lincoln's municipal well field at Ashland, the City of Ashland's municipal wells, and the Mead NOP Superfund cleanup site. M.U.D. will submit to the LPNNRD copies of all final reports submitted to the COE related to the performance of this ground water model.
- f. M.U.D. will cooperate with the LPNNRD in presenting quarterly updates to representative of the LPNNRD, Papio-Missouri NRD, affected landowners in the area of the M.U.D. Platte West Project, City of Lincoln, City of Ashland, Saunders County and M.U.D., to disseminate information regarding the M.U.D. well field located in Douglas and Saunders County adjacent to the Platte River. These updates are to be in written form and address each of the 5 previously numbered items. At the request of LPNNRD quarterly oral presentations may also be requested in a public forum open to all with time reserved for questions and answers from first the representatives and then the public as time allows.

BE IT FURTHER RESOLVED that the LPNNRD staff be instructed to continue to develop rules and regulations for presentation to the Board of Directors of the LPNNRD regarding municipal wells in the Wann Basin pursuant to the LPNNRD's Ground Water Management Plan.

Chairman Johnson reviewed the Planned Outline. Directors heard testimony from Proponents, then testimony from the Opponents. After testimony was heard Questions were asked to Directors, Staff and Legal Counsel. Finally questions and statements from LPNNRD Directors were addressed.

# b. Update on Army COE 205 Studies

#### 1. South Fremont 205

The U.S. Army COE are ready to begin the final study on the South Fremont 205 project. They must wait until the COE F.Y. 05 budget is approved which we anticipate will occur as part of the Consolidated Appropriations Bill. Congress will begin discussion on this when it reconvenes November 16.

# 2. Schuyler 205

The Schuyler 205 project has been approved for survey work by the City of Schuyler. Again we await beginning this phase 2 study until a Federal Budget is approved.

#### 3. North Bend 205

Miyoshi and Mountford met with the North Bend City Council and the COE on October 5. We were surprised when the COE offered additional alternatives to be considered for protection of North Bend. The original levee alternative has less than a 1 to 1 benefit cost ratio. The COE was directed to put together a funding package to further study levee alternatives for North Bend.

#### 6. SNITILY WETLAND PROJECT UPDATE

Murren reported Pheasants Forever and Game and Parks representatives will be here on Friday, October  $29^{th}$  for a tour of the project site\_\_\_\_

Ken Kotera proposed listing Mike Murren as the Snitily Wetland Project C.O. (Contracting Officer) to help him with project completion and paperwork. Kotera reported that this designation will allow NRCS to expedite the project and allow for continued NRD over-site of work.

Sabatka made the motion, seconded by Shelso, to list Mike Murren as C.O. (Contract Officer) for the Snitily WRP project to help expedite project completion. Motion carried on consent agenda.

#### 7. LAKE WANAHOO REPORT

Murren reported that he was in the process of adjusting the rental agreement on the Bartek farm to reflect the fisheries project work. The original agreement of 116.7 acres @ \$126.00/acre is to be revised to 81.7 acres @ \$96.00/acre. This adjustment reflects the loss of the project area and the loss of irrigated ground possible with the current pivot setup. Sabatka made the motion, seconded by Shelso, to amend the current Bartek rental contract to reflect the work completed in the fisheries project area as part of the Sand Creek Project. Motion carried on consent agenda.

#### 8. WESTERN SARPY/CLEAR CREEK LEVEE REPORT

Sabatka made the motion, seconded by Shelso, to pay \$431.64 to Mary Fertig, the previous owner of Lot #50 for property taxes paid, at closing, that have since been determined by Saunders County officials not to be due as part of the Western Sarpy/Clear Creek project. Motion carried on consent agenda.

Murren reported that no sealed bids were received for the two Western Sarpy project properties located at Thomas Lakes and that without a bid, demolition of the homes would be left to LPNNRD. There was discussion of having an auction for the two homes and contents. Murren also reported time is beginning to be a factor, as the lease on lot #42 expires December 31, 2004 and that property must be moved by that date.

Sabatka made the motion, seconded by Shelso, to advertise and auction the two properties (houses and out buildings) at the Western Sarpy project as soon as such auction can be arranged. Motion carried on consent agenda.

# 7.a. Motion to Extend "right of first refusal" Clause

Director Alm has asked that we place the following item on the additional action items for discussion and possible action. "Recommend to extend the previous owners "right of first refusal" clause in the purchase agreements for the Lake Wanahoo Project." The item was referred to the Lake Wanahoo Committee for action, followed by Projects Committee action and then action by the LPNNRD at

our December 13th Board Meeting.

#### 7.b. WS/CC Landrights - Lot 48

Mastny made the motion, seconded by Langemeier, to accept the offer on Lot 48/Larry Lindberg of Thomas Lakes as part of the Western Sarpy/Clear Creek Project. Motion carried all members present voting aye.

# 7.c. Inspection Port for Irrigation Monitoring Wells

Langemeier made the motion, seconded by Sabatka, to fund the placement of inspection ports on four of our ground water level wells at an estimated cost of \$1,880. Motion carried all members present voting aye.

### 7.d. Adolph Placek Request/Czechland Lake

Adolph Placek has 100 acres of CRP adjacent to and west of Railroad Avenue Road from Czechland Lake. Mr. Placek has been accepted to re-enroll the property into CRP and needs to commit by November 16. His current contract expires in October 2005. He is requesting that the District do his maintenance (weed control), the inter-seeding required by the Federal Contract and possibly one burn to keep it in CRP. If the District declines he will more than likely put it back into production. Through his CRP contract he is allocated \$5/acre/yr for maintenance. If put back into production, the property falls under Sod Buster. Mr. Placek would have to develop a farm plan with NRCS with acceptable soil loss levels. There is also the threat of excessive run-off, erosion and sedimentation to Czechland Lake. Mr. Placek should be informed of all his options with the farm programs and potential consequences if his property erodes excessively.

Czechland Lake receives positive benefits if this ground remains in CRP however, it is difficult to justify the District providing operation and maintenance on private land. The question we must answer is; Does LPNNRD want to take on O & M responsibility or provide financial incentives to keep this ground in CRP? The Board took no action on Placek's request.
