a. Levee Stabilization – Fremont Rod and Gun Club

Discussion took place on the levee stabilization project on Fremont Rod & Gun Club property that LPNNRD, Fremont and Dodge County assisted with emergency repair (each contributed \$36,077.50). A description of the proposed project is attached to the Projects Committee Minutes. The total project cost is \$612,380 with the hopes to receive \$450,000 from a community Block Grand (CBG). This would leave \$162,380 to be shared by local partners. The Board discussed our potential partnership and contribution to this proposed project. One important issue to address is that a public entity should take ownership of the project area (secure project easements) if additional public funding is allocated to this project, which is now on private land. Fremont was discussed as the logical entity for securing easements to establish this as a public project. Pollard made the motion, seconded by Thompson, to contribute 30% up to \$50,000 assistance to the Levee Stabilization Project on the Fremont Rod & Gun Club property contingent on an approved interlocal agreement by the partners. Motion carried.
